#### Mission Statement

Uplift's mission is to create and sustain public schools of excellence that empower each student to reach their highest potential in college and the global marketplace and that inspire in students a life-long love of learning, achievement, and service in order to positively change their world.

#### **SUMMARY**

Uplift Education will provide a centralized virtual learning option for scholars who are unable to attend school in person due to COVID health and safety protocols. Scholars who are on isolation or quarantine for 7-10 days will attend school through our centralized, virtual learning platform to continue learning. Uplift is looking for virtual classroom teachers to provide daily instruction to the students who need a centralized virtual option for a set period. Virtual teachers will deliver synchronous instruction for up to four hours daily and be expected to plan/grade for an additional hour daily. Virtual teachers will be expected to provide scholars with appropriate educational activities and experiences through a virtual instructional platform that will enable them to fulfill their potential for intellectual, emotional, physical, and social growth. This is a grant funded position funded through 9/30/2022.
